I invite your attention to the reference 1st cited wherein
the Government of A.P have decided to alienate the Government Land
directly to the individual developers by obtaining the consent to that
effect from the NDDCAP vide their letter NDDCAP/Xa/5859/96/74 dated
4.6.96 and 24.6.96 at the rate of Rs 3,000/- (Rupees three thousand only
per acre towards Market value, tentatively subject to verification of
the extents and survey numbers after preparing Sub-division records
by the Collector, Anantapur and subject to such terms and conditions as
may be specified later by the Collector besides other usual condition
under B.S.O-24.
